

By the QUEEN.
A PROCLAMATION,
For a Bank Holiday.

VICTORIA, R.

WE, taking into Our consideration that it is desirable that Wednesday, the twenty-third day of March instant, should be observed as a Holiday in the Borough of Birmingham, have thought fit, by and with the advice of Our Privy Council, and in pursuance of the provisions of "The Bank Holidays Act, 1871," to issue this Our Royal Proclamation, hereby appointing and commanding that Wednesday, the twenty-third day of this instant March, be appointed a special day to be observed as a Bank Holiday throughout the Borough of Birmingham, and We appoint Wednesday aforesaid to be observed accordingly.

Given at Our Court at *Windsor*, this seventh day of *March*, in the year of our Lord one thousand eight hundred and eighty-seven, and in the fiftieth year of Our reign.

IT is this day ordered by Her Majesty in Council that the Right Honourable the Lord High Chancellor of that part of the United Kingdom called Great Britain do cause the Great Seal to be affixed to a Proclamation directing that Wednesday the twenty-third day of March one thousand eight hundred and eighty-seven be observed as a Bank Holiday in the Borough of Birmingham.
